# Kestrel Celebrates 50 Years with a Big Move


Kestrel Land Trust will move to a new "home on the Range" in South Amherst starting in 2021. The property was acquired as part of a collaborative conservation project with the Town to acquire and permanently conserve the adjacent 7-acre pond and the surrounding 30 acres of woods. Located contiguous to the Atkins Farms Village Center Kestrel will work with the Town to enhance public access to the pond and trails from trailheads at the foot of the Mount Holyoke Range. ### **State Operating Budget**

On Nov. 5, the Massachusetts House released their FY21 Operating Budget, which included increases over the Governor's revised budget for all four of the Green Budget Coalition's priority line items: the Department of Environmental Protection (DEP), the Department of Conservation and Recreation (DCR), the Division of Ecological Restoration (DER), and the Natural Heritage and Endangered Species Program (NHESP). See summary here. In addition, we are grateful to Rep. Ruth Balser for filing the Public Lands Protection Act as an amendment (#23). The House budget debate will conclude this week. The Senate will put out their version of the budget very soon. Now is the time to reach out to your state Senators (find yours here) and ask that they maintain House funding levels for the Green Budget Priorities. ### Take Action: Protect Federal Tax Incentives for Conservation

Not all donations of conservation easements are created equal. While the vast majority are truly charitable endeavors, a few bad actors are promoting conservation easement donations as a way for investors to make a fast profit by gaining access to very large federal tax deductions. These transactions are essentially tax shelters and cannot be allowed to continue. Please encourage your Congressperson to urge the passage of the Charitable Conservation Easement Program Integrity Act this year. To take action, see <u>details here</u>.

# Level 2 - Significant Drought in the Southeast and Cape Cod Regions and the Nashua River watershed

Although drought conditions have improved in most regions of the Commonwealth since last month's Level 3-Critical conditions in the Southeast region, water conservation is still necessary. The Cape Cod Region Remains at Level 2-Significant Drought. In the Connecticut River Valley, Central, Northeastern, and Islands regions, conditions improved to a Level 1-Mild Drought. To enhance awareness on the current drought conditions, EEA is asking local, state and regional partners and stakeholder groups to assist in disseminating this critical information. ### **Nine New Communities Adopt CPA**

A total of three cities and six towns voted in favor of adoption of the Community Preservation Act (CPA), all by a wide margin: Framingham, Franklin, Greenfield, Hopedale, Lancaster, Lee, Milton, Shrewsbury, and Whitman. This brings the total number of CPA communities to 186, or 53% of municipalities in Massachusetts. <u>Read more</u>. # The 300 Committee Land Trust Quietly Celebrates 35 Years During Pandemic

The 300 Committee (a.k.a. T3C) was formed in 1985 with the goal of saving 300 acres of open space to celebrate Falmouth's 300th anniversary the following year. Since then, it has preserved more than 2,500 acres all over Falmouth, from farmlands to woodlands, from a third of an acre acquired in 1986 to the 70-acre Shallow Pond Woodlands south of Thomas Landers Road. Says Mark H. Robinson, Executive Director of Cape Cod Conservation Trusts, the umbrella organization for all Cape Cod land trusts: "I consider The 300 Committee as one of the flagship land trusts on Cape Cod due to its longevity, sophistication and ability to get things done. It is looked at with great envy by many other towns on Cape Cod and nonprofit organizations concerned with the critical issues of preserving open space." Read more.

### One Simple Thing That Will Greatly Improve Your CPA Program

When a Community Preservation Committee (CPC) votes to recommend a project to the legislative body (Town Meeting or City Council), they often miss the simple step of sending a formal, written recommendation to their municipal officials. There are many items that should and can be included in a recommendation. Though there is no requirement in CPA legislation for a written recommendation, communities that use them have far fewer problems during the implementation stage of projects. #### Some Like It Hot. Trout Do Not.

In a changing climate, brook trout and other species that rely on cold water may have a hard time finding suitable habitat year-round. Partners are working to gather data and find patches of cold water where fish can shelter during heat and drought. One such partnership involves the Nashua River Watershed Association (NRWA), the Squan-a-Tissit Chapter of Trout Unlimited (TU), and MassWildlife. Partners are tracking stream conditions to inform habitat improvement and stewardship efforts on the watershed level. Acquiring land or otherwise protecting areas from development within the watershed is one key way to safeguard areas of cold water refugia. Read more.

#### Stuart Saginor Presented with the Lewis Conservation Award

Since becoming Executive Director of the Community Preservation Coalition in 2006, Stuart has helped almost 100 cities and towns in Massachusetts adopt the Community Preservation Act, and most recently spearheaded last year's efforts to increase state funding for the CPA program by 150%. The Lewis Conservation Award is named in honor of co-founder of the Sudbury Valley Trustees, George Lewis, and it recognizes those who demonstrate a broad commitment to conservation in the SVT region and who encourage others to take action to protect the environment. The Baker-Polito Administration awarded \$500,000 in grants to regional Buy Local organizations for projects that will support the agricultural industries in western, central, northeastern, and southeastern Massachusetts. These grants build upon the administration's efforts to support regional economies across the Commonwealth. On August 25, 2020, the Administration announced the launch of the "My Local MA" campaign to encourage residents to support their local economies by shopping at local Massachusetts businesses and attractions, either in person, online, or by using curbside pickup or takeout. 



# MDAR SARA grant for APR landowners (SARA = Stewardship Assistance and Restoration on APRs)

**Deadline**: Friday, December 18, 4:00 pm at the Boston MDAR office or emailed to julie.weiss@mass.gov This grant is intended to help APR landowners restore APR land that was once in agricultural production to be put back into production. In addition, funds may be used to restore farm resources that have been negatively impacted by flooding, erosion, storms, tornadoes and other natural disasters or for restoration on land impacted by a third party.

## Land and Water Conservation Fund (LWCF) Grant Program

Deadline: February 1, 2021, 3:00 pm

The LWCF grant program provides financial assistance to municipalities and the state's Departments of Conservation and Recreation and Fish and Game for the acquisition of parkland, development of a new park, renovation of an existing park, development of trails in an existing conservation or recreation area, or the acquisition of conservation land. Grants up to \$1,000,000 are available this grant round. **Two virtual grant workshops** will be held, the first on Wednesday, December 2 at 2:00 pm and the second on Thursday, December 10 at 11:00 am.
