# 140-Acre Gift of Art and Land Finalized in Shutesbury

In 1976, Julian Janowitz bought a remote forested property near Lake Wyola in Shutesbury, which became, according to his obituary, "a big, three-dimensional canvas for [his] creativity". This special property, known to his friends as "Julian's Bower", is a landscape of wetlands and forest traversed by 5 miles of trails leading to a dramatic cliffside overlook. The land is dotted with Julian's whimsical modern wood, glass, and stone sculptures, as well as his poetry. The property includes the 22-acre Ames Pond and its adjoining bog with a several-hundred-foot-long boardwalk—built by Mark

himself. He began protecting the property with a conservation restriction in 2003 with the help of Kestrel Land Trust, and in 2016 contacted Kestrel again to ensure that the experience of art and nature on his land would be enjoyed by the public in perpetuity. When Julian passed away in 2019, his will - finalized in July 2021 - left this 140-acre natural "canvas" to Kestrel, which now owns and stewards the land. Read more.

# **Policy**

### Conservation to Receive a Share of ARPA Funding

A House-Senate Conference Committee is currently working to reconcile differences between their respective proposals for spending the first installment of \$4.9B in American Rescue Plan Act (ARPA) funding coming to Massachusetts, with a goal of sending a bill to the Governor before Thanksgiving. Funds will address a broad range of community needs, including environmental

concerns such as improved water infrastructure, land acquisition and park creation, tree-planting, green jobs, and climate resiliency. Next year, the legislature will take up plans to spend the remainder of ARPA funds.

### Water Quality and Climate Resiliency Benefit from Federal Infrastructure Package

The trillion-dollar infrastructure package signed into law by President Biden on November 15 is slated to bring over \$9 billion in funding to Massachusetts over the next five years, including funding to upgrade wastewater infrastructure, improve energy efficiency and reduce climate-change impacts to communities. ### **Comments sought on Draft Environmental Justice Protocols**

Deadline: Friday November 26

The Massachusetts Environmental Policy Act (MEPA) Office has issued two protocols relative to environmental justice for public comment. Public comments can be submitted by November 26, 2021 to MEPA-regs@mass.gov. More information here. These protocols will supplement proposed amendments to MEPA regulations planned for final promulgation by December 2021. In addition, a new MEPA Interim Protocol on Climate Change Adaptation and Resiliency is now in effect as of October 1, 2021.

### Input Sought on Clean Energy and Climate Plans for 2025 and 2030

Under the Next-Generation Roadmap for Massachusetts Climate Policy bill that was signed into law last March, the Executive Office of Energy and Environmental Affairs (EEA) is required to set emissions-reductions targets every 5 years, with detailed plans for reaching them. As the state writes rules and makes plans related to addressing climate change, they need to hear from conservationists, farmers and environmental justice advocates about their specific ideas, needs and priorities. ### **NOAA Requests Public Input**

Deadline: Tuesday, December 28

NOAA welcomes public input on how it can advance the <u>goals and recommendations in the report on "Conserving and Restoring America the Beautiful</u>". The Report recommends a decade-long national initiative to promote locally led conservation and restoration in public, private, and Tribal lands and waters to address three threats: 1) disappearance of nature loss, 2) climate change, and 3) inequitable access to the outdoors. <u>Learn more and provide your input</u>.

### Mark Anderson Named Kingsbury Browne Fellow

Mark Anderson was recently named a <u>Kingsbury Browne Fellow</u> at the Lincoln Institute of Land Policy, and is the recipient of the <u>Kingsbury Browne Conservation Leadership Award</u> from the Land Trust Alliance. Mark is director of The Nature Conservancy's Center for Resilient Conservation Science, and an ecologist who has conducted groundbreaking work to map climate-resilient lands and waters across the United States. These maps are used by government agencies, land trusts, and other organizations to prioritize conservation work. <u>Read more</u>.

#### CPA Trust Fund Breaks a New Record

Over \$79 million has been distributed to CPA communities this year, an all-time high for the statewide program. All CPA communities received a 39.4% match on round one of the trust fund distribution. Barnstable Clean Water Coalition Receives First-Ever SNEP Pilot Watershed Grant BCWC was awarded a 5-year \$750,000 Southeast New England Program (SNEP) Pilot Watershed

grant from the Environmental Protection Agency. As one of four recipients of this new grant program, BCWC will use their award to help restore 56 acres of cranberry bogs at the headwaters of the Marstons Mills River to a natural wetlands system. An estimated 40% of the excess nitrogen load for Three Bays Estuary transits these cranberry bogs. The grant will fund design, permitting, and a portion of the implementation of the bog restoration. 

### **Neighborhood Outreach Project**

Deadline: rolling

The Working Forest Initiative is sponsoring grant funding to implement "neighborhood-based outreach" to landowners about conservation-based estate planning, including land protection options. This project aims to use social networks to help inform landowner decisions about the future of their land. This grant is intended for areas with significant forest cover. Maximum funding is \$5,000. All activities of this reimbursement grant must be completed by April 15, 2022. Details here.

### **Remote Monitoring Grants**

These Remote Monitoring Grants from the Land Trust Alliance support land trusts in exploring how remote monitoring technologies can help to enhance their stewardship work. ### **Farm Credit East AgEnhancement Grants**

Grants of up to \$10,000 will be awarded to support programs, projects, and activities that assist in the development of young and beginning farmers; encourage leadership development with the aim of strengthening agriculture and the food and fiber industries; generate a greater understanding and appreciation of agriculture and the food and fiber industries in the region; recognize the accomplishments of leaders of the agriculture and food and fiber industries; advance the economic viability of agriculture and the food and fiber industries in the Northeast; and/or promote interest in agriculture/horticulture/forest products/commercial fishing. ### **Temper of the Times Grant Program**

Application Deadline: Wednesday, December 15

Temper of the Times Foundation provides funds to underwrite advertising designed to promote the

conservation and restoration of native wildlife, plants, and ecosystems in the United States. Grants ranging from \$5,000 to \$15,000 may be used to fund the production of print, radio, or television ads; to pay for advertising space or airtime; or to produce or distribute pamphlets, books, videos, or press packets. ### Municipal Vulnerability Preparedness (MVP) Planning Grant

Application deadline: Friday, January 7, 4:00 p.m.

The MVP Planning Grant offers funding to municipalities that want to assess their vulnerability to, and prepare for, climate change impacts, build community resilience, and receive designation from the Executive Office of Energy and Environmental Affairs (EEA) as an MVP Community. MVP Communities are eligible for MVP Action Grant funding to implement the priority actions identified through the planning process. Learn more.

### **Community Forest and Open Space Conservation Program Grants**

Application deadline: Monday, January 10

Local governments, qualified nonprofit organizations, and Indian tribes are eligible to apply for grants to establish community forests through fee simple acquisition of private forest land by protecting it from conversion to non-forest uses, and to provide 1) community benefits such as sustainable forest management; 2) environmental benefits including clean air, water, and wildlife habitat; 3) benefits from forest-based educational programs; 4) benefits from serving as models of effective forest stewardship; and 5) recreational benefits secured with public access. ### **Land and Water Conservation Fund Grant Program**

Deadline: Monday, January 24, 2022 at 3:00 pm

The LWCF grant program provides financial assistance to municipalities and the state's Departments of Conservation and Recreation and Fish and Game for the acquisition of parkland, development of a new park, renovation of an existing park, development of trails in an existing conservation or recreation area, or the acquisition of conservation land. Grants up to \$1,000,000 are available this grant round. MassTrails provides matching grants to communities, public entities, and non-profit organizations to plan, design, create, and maintain the diverse network of trails, trail systems, and trails experiences used and enjoyed by Massachusetts residents and visitors. <u>Details here</u>.

### **Small Communities Grants**

Deadline: Rolling, with a final deadline of May 6

The <u>Small Communities Grant Program</u> provides funding to municipalities with 6,000 or fewer residents to produce Open Space and Recreation Plans, complete other plans to facilitate land conservation, and/or prepare appraisals as required to apply for other <u>Division of Conservation Services grant programs</u>. Applications are accepted on a rolling basis. The final deadline is May 6. <u>Apply here</u>.
