## **ACTION ALERT**

## 1) Action Alert: Conservation Land Tax Credit

Please contact your Massachusetts State Senator ASAP and ask him/her to support an amendment (to be filed by Senate Minority Leader, Senator Bruce Tarr) to the State Operating Budget, which would increase the annual cap for the Conservation Land Tax Credit (CLTC) program.

All it takes is a quick call or email to their office (under five minutes). The land community needs to make contact now as legislative offices will be flooded with requests from other advocates. Contact information for your legislator (searchable by municipality) can be found <u>here</u>. For a fact sheet on the CLTC program and proposed changes, please click <u>here</u>. The amendment will be identical to that which passed the House.

Below is a sample call "script" and email that you can send to your State Senator (feel free to augment it with the additional information in the fact sheet or a story about a landowner you worked with who has been able to take advantage of, or is on the wait list for, the tax credit).

Dear Senator \_\_\_\_\_: As part of a [land conservation organization] in your district, I am contacting you to ask you to co-sponsor and support an amendment to the Senate

budget for the Conservation Land Tax Credit program filed by Senator Bruce Tarr. The amendment would increase the annual cap to eliminate the backlog of this successful program and enable our organization to collaborate with private landowners to conserve land for farming, forestry, wildlife and clean water.

Thank you for your consideration of this request.

## 9) Energy & Environmental Affairs Park & Conservation Grants

The Executive Office of Energy & Environmental Affairs' Division of Conservation Services (DCS) is seeking applications for the FY 2019 <u>Parkland Acquisitions and Renovations for</u> <u>Communities</u> (PARC), <u>Local Acquisitions for Natural Diversity</u> (LAND), and <u>Conservation</u> <u>Partnership</u> grants. PARC grants help communities acquire parkland, develop new parks, and renovate existing parks. LAND grants provide funds to municipal conservation commissions to purchase conservation land and conservation restrictions. Conservation Partnership grants provide funds to nonprofit organizations for land acquisitions. DCS will hold two workshops for the PARC and LAND grants-on May 16 at 11:00 am in Amherst and on May 17 at 11:00 am in Boston. PARC and LAND grant applications are due by July 12. Conservation Partnership applications are due by July 16. #### **10) MA Municipal Vulnerability Preparedness (MVP) Program** Excerpts from Energy & Environmental Affairs, April 13, 2018 by Peter Lorenz

Continuing its commitment to working with communities and local partners to prevent and prepare for climate change, the Baker-Polito Administration has announced \$5 million in supplemental funding for the <u>Municipal Vulnerability Preparedness (MVP)</u> <u>Program</u>. The grant and designation program, which was created last year as part of Governor Baker's <u>Executive Order 569</u>, provides communities with funding, technical support, climate change data and planning tools to identify hazards, develop strategies to improve resilience, and implement priority actions to adapt to climate change. Rare, Conservation International, National Geographic, The Nature Conservancy, The United Nations Development Programme, and the World Wildlife Fund have teamed up to launch The Solution Search Contest: Climate Change Needs Behavior Change. This contest is designed to reward successful strategies for helping consumers reduce their carbon footprint through behavior change. The contest is open to all organizations worldwide who have a proven solution in working with people to adopt climate-friendly behaviors. The focus is on sustainable solutions that could be replicated by other communities and can continue into the future. Two grand prizes of \$25,000 will be awarded, in addition to a prize of \$5,000 given to the best entry received by June 1, 2018. ## **14) Open Space Institute: Community Forest Fund** June 18, 2018 deadline

The Open Space Institute (OSI) protects scenic, natural, and historic landscapes to provide public enjoyment, conserve habitat and working lands, and sustain communities. OSI's Community Forest Fund awards grants in the northern New England states of Maine, New Hampshire, and Vermont. The focus is on projects that integrate community, economic, and conservation goals, such as efforts that create and retain jobs, promote sustainable forestry, conserve land, and increase and deepen community involvement in land stewardship. The Fund awards matching capital grants to support the purchase of conservation easements and fee interest in land.
